RESOLUTION 2017-05**

Rising Sun 2017 Update to the Cecil County Master Water and Sewer Plan

WHEREAS, the Town, located in Cecil County, Maryland is a municipality organized under the provisions of the Maryland Constitution and governed under the provisions of the Local Government Article of the Annotated Code of Maryland; and

WHEREAS, the Town is proclaimed as a perpetual entity with the right to pass laws; and

WHEREAS, Section 9-503 of the Environment Article of the Annotated Code of Maryland requires Cecil County to have a Water and Sewerage plan; and

WHEREAS, Section 9-504 of the Environment Article of the Annotated Code of Maryland requires subsidiary plans for any town and or municipal corporation that has existing or planned development in the County and those plans may be incorporated into the county's plan; and

WHEREAS, the subsidiary plan for the Town of Rising Sun's water and sewer systems is currently listed in sections 4.1.8 and 3.2.9 respectively of the Cecil County Master Water and Sewer plan adopted January of 2015; and

WHEREAS, the Town of Rising Sun has moved forward with the replacement of its existing water distribution system with a new water supply provided by the Chester Water Authority (CWA), operating out of Pennsylvania, as spelled out and described in section 3.29 (B) of the adopted plan; and

WHEREAS, the final design of this water line requires a text amendment to the existing plan and updates to the Master Water Plan Water Service District map.

THEREFOR, the Mayor and Commissioners have reviewed the attached 7 page application packet and hereby approve of these text amendments and map updates and further authorize the formal submittal of these documents to the Cecil County Planning Commissioner and County Council for their review and consideration.

THEREFORE BE IT FURTHER RESOLVED that the Mayor and Commissioners of the Town of Rising Sun passed, approved, and adopted this resolution on this 25th day of April, 2017.






