## TOWN OF RISING SUN RESOLUTION 2012-07

WHEREAS, the Town, located in Cecil County, Maryland is a municipality organized under and governed by Article 23A of the Annotated Code of Maryland; and

WHEREAS, the Town is proclaimed as a perpetual entity with the right to pass laws; and

WHEREAS, Section C-16 of the Town Charter, titled <u>General Powers of Town</u>, note (2) titled <u>Specific Powers</u>, sub note (17) titled <u>Finances</u>, grants the Town Commissioners with the specific powers of general management and control of the finances of the Town; and

WHEREAS, the Mayor and Commissioners previously adopted a fiscal policy manual which established policies and procedures for internal controls and to ensure the timely processing of bills and collection of monies owed to the town and the reliability of financial processes, reporting and accountability; and

WHEREAS, the Mayor and Commissioners previously adopted resolution 2010-11 which established the general operation and guidelines for the establishment and maintenance of Town Safety Deposit Boxes, Bank Accounts, Investment Funds, and other similar financial instruments; and

WHEREAS, the Mayor and Commissioners deem it necessary to update and to reaffirm by resolution these procedures; and

WHEREAS, the Mayor and Commissioners wish to establish Commissioner Joanne Osborne, Town Administrator Calvin A Bonenberger Jr and Commissioner Stephen Naughton with prior authorization to sign any forms, contracts or agreements on behalf of the Town of Rising Sun, for the establishment of safety deposit boxes and general banking and financial services for the Town, to include checking and savings accounts, CD's, money markets and other similar financial and investment instruments, and to perform all general activities associated therewith to include serving as the required signatures on all checks, deposits, withdrawals and fund transfers as needed and in accordance to the Town's Fiscal Policies.

NOW THEREFORE BE IT FURTHER RESOLVED that the Mayor and Commissioners of the Town of Rising Sun passed, approved and adopted this resolution on this  $10^{th}$  day of JULY, 2012
