

# TOWN OF RISING SUN RESOLUTION 2012-09

**WHEREAS**, the Town, located in Cecil County, Maryland is a municipality organized under and governed by Article 23A of the Annotated Code of Maryland; and

**WHEREAS**, the Town is proclaimed as a perpetual entity with the right to pass laws;  
and

**WHEREAS**, the Mayor and Commissioners wish to promote the safety, health and general welfare by regulating smoking in buildings and vehicles owned by the Town of Rising Sun; and

**WHEREAS**, the Mayor and Commissioners are hereby adopting the following policies in regards to smoking in Town owned buildings, structures and vehicles, and that this policy will become a part of the Town's personnel manual and will be included in any future upgrades to the manual.

**NOW THEREFORE BE IT RESOLVED**, that effective immediately, no person shall cause, allow or permit any person to smoke cigarettes, cigars, pipes or other devices containing tobacco or other combustible smoking materials, to include chewing tobacco etc, in the interior of any buildings, structures or vehicles owned, leased or controlled by the Town of Rising Sun.

**NOW THEREFORE BE IT FURTHER RESOLVED** that the Mayor and Commissioners of the Town of Rising Sun passed, approved and adopted this resolution on this 28<sup>th</sup> day of August, 2012




