NOW THEREFORE BE IT RESOLVED, that effective immediately, no person shall cause, allow or permit any person to smoke cigarettes, cigars, pipes or other devices containing tobacco or other combustible smoking materials, to include chewing tobacco etc, in the interior of any buildings, structures or vehicles owned, leased or controlled by the Town of Rising Sun.

NOW THEREFORE BE IT FURTHER RESOLVED that the Mayor and Commissioners of the Town of Rising Sun passed, approved and adopted this resolution on this 28<sup>th</sup> day of August, 2012
