


# TOWN OF RISING SUN MAPLE HEIGHTS DEVELOPMENT TOWN MEETING MINUTES



Let it be remembered that the Mayor and Board of Commissioners of the Town of Rising Sun held a Town Workshop Meeting at the Rising Sun Fire Hall on Thursday evening September 6, 2012. For the record the meeting place and time were duly posted as required.

<u>MEETING OPENING</u> – The meeting was called to order at 7 : 01 PM by Mayor Robert Fisher, followed by the pledge of allegiance, and a moment of silence.

<u>Meeting Purpose</u>; Mayor Fisher stated that the purpose of tonight's meeting is to entertain motions to rescind Resolution 2012-10.

Mayor Fisher introduced Mr. George Beer representing the Delaware Valley Development Organization, and the Maple Height Phase II proposal for development.

Mr. Beer explained in detail the demographics of the proposed Phase II and the existing Maple Heights apartments, stating that 25 to 28% of the existing residents are elderly or disabled and 5 to 6 residents are Section Eight housing.

• Many residents of Maple Heights shared their concerns about the development of Phase II.


