

**TOWN OF RISING SUN
RESOLUTION 2017-03**

**Planning Commission and Board of Zoning Appeals
Terms of Appointment**

WHEREAS, the Town, located in Cecil County, Maryland is a municipality organized under the provisions of the Maryland Constitution and governed under the provisions of the Local Government Article of the Annotated Code of Maryland; and

WHEREAS, the Town is proclaimed as a perpetual entity with the right to pass laws; and

WHEREAS, the Code of Ordinances of the Town, contains Chapter 2, titled ADMINISTRATION & GOVERNMENT, which establishes the general guidelines associated with the proper administration of affairs and business for the Town of Rising Sun, Maryland, in accordance with the Town Charter and other applicable Federal and State Laws; and

WHEREAS, this Chapter, contains Article 2, titled ORGANIZATION OF GOVERNMENT, which establishes the various responsibilities of the Mayor and Commissioners, creation and structure of various staff positions, appointed consultants, departments and appointed boards that handle the day to day administration of the Town Government as set forth by the Annotated Code of Maryland, Town Charter and Town Code; and

WHEREAS, this Article, contains Section 2-209, titled CREATION AND ADMINISTRATION OF A PLANNING COMMISSION AND BOARD OF ZONING APPEALS, which further establishes the creation of both a Planning Commission and Board of Zoning Appeals and further establishes their membership, terms of appointment, removal, vacancy meetings, rules of conduct and records; and

WHEREAS, this section specifically calls for terms of appointment; and

WHEREAS, there has been a significant amount of turnover on both boards and the Mayor and Commissioners would like to reaffirm the persons appointed to these boards with clear definition of their terms of appointment; and

WHEREAS, the Mayor and Commissioners would like to reappoint the following persons to the below listed boards and for those persons to further serve in those appointed positions in accordance to the above code sections and until their successors are dully appointed. Positions to fill the vacancies listed below will be put forward at a later date.






