PUBLIC NOTICE OF PUBLIC HEARING ZONING CODE UPDATES & PHASE I COMPREHENSIVE REZONING

Public notice is hereby given that the Mayor and Commissioners shall be holding a public hearing at the Community Fire Company of Rising Sun, located at 300 Joseph Biggs Memorial Highway on Tuesday March 22nd, 2022, at 7:00 PM.

The purpose of the hearing is to receive public comment on two ordinances up for consideration by the Mayor and Commissioners. Ordinance 2022-01 titled "Amending and Creating Zoning Districts", is an ordinance that will amend existing zoning districts while also creating new zoning districts as recommended in the Town's 2019 Comprehensive Plan Update.

Ordinance 2022-02 titled Comprehensive Rezoning -Phase 1, is an ordinance that will amend the zoning classification of certain properties as recommended in the Town's 2019 Comprehensive Plan Update and as summarized below:

The reclassification of zoning for the above properties is recommended to eliminate "spot zoning" and properties that are not compatible with surrounding properties of similar use and intensity and to further provide for the coordinated and harmonious development of the Town and to incorporate best practices for promoting health, safety, morals, order, convenience, prosperity, and general welfare. The proposed changes are based upon a comprehensive review of population change, adequacy of public facilities, present and future transportation patterns, compatibility with existing and proposed development for the area, fiscal impact upon Town government, and the suitability of the property in question to the uses permitted under the existing and proposed zoning classifications.
